The Scio Town Board meeting began at 6:30pm with the supervisor Kim Demick calling the meeting to order with reciting the Pledge of Allegiance to the Flag.

Water Dept: Board discussed the water rates for 2019 and Kim Demick made the motion to increase the base rate \$1.00 from 2.50 cf. to 2.60 cf. Jennifer Goodridge seconded it. All in favor aye vote approved. Discussed the possibility of ordering more meters. Dylan is waiting for a quote to get overall cleaning and painting of tank and see what it's going to take. Motion to accept the water bills was made by Jennifer Goodridge and seconded by Crystal Wiech. All in favor aye vote approved.

Highway Dept: Motion to approve the monthly highway bills was made by Crystal Wiech and seconded by Jennifer Goodridge. All in favor aye vote approved. Skip discussed the pipe on Bill Allen Hill Road costing \$6500.00. No quote yet on fixing suspension on the 2013 Mack truck. Needs to be fixed by plowing season. The GMC new windshield is in and brake line for \$552.00. Needs new tires to be bought this fall, not much left in inventory. Will cost \$4000.00 or less. He is ordering plow blades which will cost \$4100.00. Three bridges have been painted. The Linko belt excavator has 300 hours on it, we can get for \$160,000.00 with buckets. Sand and salt cost \$22,000.00 this year which leaves \$10,000.00 to use towards the excavator. Crystal made a motion that the highway department purchase the 2015 linko belt excavator and it is to be funded by chips and highway fund. Jennifer Goodridge seconded it. All in favor aye vote approved. Skip also mentioned that we will probably have to replace his truck in 2020.

Jennifer Goodridge made a motion to cash the cd's in the amount of \$118,700.00 and deposit into Highway checking. Kim Demick seconded it. All in favor aye vote approved.

Kim Demick made a motion to accept minutes from the previous month's meeting. Seconded by Jennifer Goodridge. All in favor aye vote approved.

Motion to approve the monthly general bills was made by Crystal Wiech and seconded by Kim Demick. All in favor aye vote approved.

Bookkeepers Report: Bookkeeper submitted report.

Town Clerk: Monthly reports passed around for review with a copy being kept on file in the clerk's office. The town clerk went to a training to become a Notary and will be scheduling a date to take exam sometime in the future.

Concerns of Attendees: A concerned citizen voiced his concern over the \$20.00 late fees that he has been charged. The board will discuss the situation.

Crystal Wiech made a motion to reduce a customer's late fees from \$120.00 to \$60.00. Kim Demick seconded it. All in favor aye vote approved.

Supervisor: Kim made a motion to accept the ambulance contract with the Wellsville Volunteer Ambulance. Jennifer Goodridge seconded it. All in favor aye vote approved.

There will be a public hearing held by the Town Board of Scio on November 14th at 6pm located at the Scio Town Hall for review of the Preliminary budget for the fiscal year beginning January 1, 2019.
