Everyone welcomed new board members John Ramsey and Kyle Spier to their very first board meeting.

Dog Control: Monthly report copied and passed out for review. Kept on file in the town clerk's office.

Code Enforcement: Monthly report copied and passed out for review and kept on file in the town clerk's office.

Water Dept.: Dylan was absent. Board went over all bills and Crystal Wiech made a motion to accept water bills and seconded by John Ramsey. All in favor aye vote approved. Kim made a motion to appoint Dan Jordan as a consultant for the Water Dept. Crystal Wiech seconded it. All in favor aye vote approved.

Highway Dept.: Skip Nickerson handed in paper work on all the work that was done in 2018 on all roads. He stated he would like to see about getting a back-up worker if someone is off. The board will talk about it. Skip also said we need the mutual aid agreement on the 2013 Mac. Clutch is bad and will cost between \$3000- \$4000 to put new clutch in. Supervisors Report: Supervisor appointed each board member to be the liaison for each of the town's departments. Kyle Spier will be the liaison for the Highway Department. Crystal Wiech will be the liaison the water department. Jennifer Goodridge will be the liaison for the Judges

and Fire Department. John Ramsey will be the liaison for the cleaner, dog control office and the crossing guard. Kim Demick will be the liaison for the CEO, Clerk's office and the Assessor.

Kim Demick set up audits for Town Clerk to be held on January 19th at 9:30am and Judges audit is to be scheduled at a later date.

Torey Scotchmer will be a backup for the Crossing Guard. Kim Demick made a motion to pay back up crossing guard \$11.10 per hour which is minimum wage. Kyle Spier seconded it. All in favor aye vote approved.

Kim Demick also make a motion to hire Southern Tier West up to \$800.00 to update all our files, Crystal Wiech seconded it. All in favor aye vote approved.

Kyle Spier made a motion to purchase a new copier for the water / Supervisor and Bookkeeper. Kim Demick seconded it. All in favor aye vote approved.

Kim Demick made a motion to approve the Fire Dept contract of \$102,000.00. Jennifer Goodridge seconded it. All in favor aye vote approved.
